BID SPECIFICATIONS 302 W JEFFERSON ST ROOF REPAIR

- The city of Elkton is accepting sealed bids for various roof repairs of the building owned by the city located at 302 W Jefferson Street in Elkton, Kentucky.
- Contractor must furnish all materials, equipment and labor to complete the following services on the building:

Bid Item 1 - High Ceiling Area (See Attached)

- Remove all wooden walk paths on the roof area.
- Clean all areas where the walk paths were and screws are, replacing all screws as needed.
- Install one new coat of RC-2000 Inland Coating (or equal), herein referred to as
 "coating," to match existing color as close as possible over screws and holes from
 walk paths. If not using RC-2000 Inland Coating, please submit brand and
 specifications for coating being used.
- Install new mesh over coating.
- Install one new coating over mesh.
- Install new coating application as above on all rust areas.
- Install new coating application as above on all curbs and vents.
- Take out existing smoke stack completely and cover roof with new sheet metal over proper framing.
- Clean up and haul off all debris to proper disposal facility.
- Provide two year workmanship warranty on work stated above.
- Also, provide 6 month warranty on missed leaks.
- Other recommendations and with additional cost may be noted on a separate attachment to the bid form.

Optional Bid Item - Lower Industrial Section (See Attached)

- Make same repairs as stated above on the Lower Industrial Section.
- 3. Contractor must furnish, at a minimum, proof of insurance as follows: \$1,000,000.00 General Liability Each Occurrence, \$2,000,000 Aggregate, and \$1,000,000.00 Workers Compensation. Contractor will be required to provide certificate of insurance with the City of Elkton, Kentucky listed as an additional insured before contract begins.
