PROPER DRAINAGE SHALL BE ESTABLISHED DURING DEMOLITION TO PREVENT ACCUMULATION OF WATER OR DAMAGE TO ANY ADJOINING PROPERTY. BY SIGNING THIS AGREEMENT, YOU ALSO ARE CONFIRMING YOUR RECEIPT OF A COPY OF THE FULL ORDINANCE
