# INVITATION TO BID ASPHALT SURFACING

The city of Elkton, Kentucky is now accepting sealed bids for Asphalt Surfacing of various city streets in the city of Elkton, Kentucky. Specifications and bid form may be picked up at City Hall, 71 Public Square, Elkton, Kentucky during normal business hours of 7:30 am to 4:00 pm, Monday through Friday, or by contacting City Hall at 270-265-9877 or by visiting www.elktonky.com.

Contractor must be pre-qualified to do work for the Commonwealth of Kentucky, Transportation Cabinet, Department of Highways, for work to be performed.

Bids shall be sealed in an envelope clearly labeled with "Asphalt Surfacing Bid" and mailed or hand delivered to City of Elkton, City Hall, PO Box 578, 71 Public Square, Elkton, KY 42220. No facsimile bids will be accepted. Bids shall be submitted on the bid form provided in the specifications and will be accepted until **Tuesday**, **October 29**, **2019 at 10:00 AM**. Bids will be opened at this time and will be presented to the City Council for review at a public meeting.

The City of Elkton reserves the right to accept any bid, to reject any or all bids, and to waive any technicality or informality in bidding or bids received, where such acceptance, rejection, or waiver is considered to be in the best interest of the city. All qualified applicants will receive consideration for employment without regard to race, religion, color, national origin, sex, sexual orientation, gender identity, age or disability. The City of Elkton is an Equal Opportunity Employer.

#### SPECIFICATIONS

- 1. Cut back all debris and grass growing on edges of existing pavement.
- 2. Clean, sweep and spray weed killer on streets on as needed basis.
- 3. Edge keys are to be cut at terminal ends of overlay.
- 4. Furnish and install all manhole and water valve risers where required.
- 5. Milling and base repairs as noted where needed.
- 6. Apply a bituminous tack coat at a rate of  $0.06 \text{ gal/yd}^2$ .
- 7. Level as needed and install 2.0" compacted asphalt surface mix.
- 8. Areas to be serviced:
  - **Marion Street:** Starting at West Main Street intersection approximately 14'wide going to College Street approximately 410' long. Base failure repair needed in area of approximately 30 yd<sup>2</sup> as marked with orange paint by excavating as needed to install 6" DGA stone and 3" base asphalt mix prior to surface installation.
  - Elk Fork Road: Starting at West Main Street intersection approximately 80' wide going northerly and ending approximately 98' long by 32' wide.
  - **B White Road:** Starting at West Main Street intersection approximately 60' wide going northerly and ending approximately 190' long and 16' wide.
  - **Glenn Court:** Starting at South Main Street intersection approximately 23'wide going approximately 710' long to dead end.
  - **Don Drive:** Starting at Pond River Road intersection approximately 36' wide going southerly and ending approximately 75' long and 20' wide.
  - North Allen Street: Starting at East Main Street going approximately 1,155' long with varied widths 20'/24' to new paving joint on Water Street. Base failure repair

needed in area of approximately 14  $yd^2$  as marked with orange paint by excavating as needed to install 6" DGA stone and 3" base asphalt mix prior to surface installation. Mill longitudinal edge keys from East Main Street to East Jefferson Street.

- South Allen Street: From East Main Street intersection going approximately 1,140' long with varied widths 18'/22' to Goebel Avenue. Mill longitudinal edge key along Haley Hardware parking lot.
- **East Washington Street:** Starting at new pavement joint on East Washington Street near garden homes approximately 21' wide going approximately 630' long to Allensville Street.
- **Elk Street:** From North Main Street approximately 20' wide going approximately 545' long to North Allen Street.
- **Duke Street:** Starting at College Street intersection approximately 17' wide going approximately 965' long to Olive Street.

# ASPHALT SURFACING

Bid submitted shall be for providing all labor, equipment, and materials necessary to place and compact asphalt surface material. Tack shall be applied to existing asphalt surfaces which will contact new asphalt.

# OTHER

Contractor shall be responsible for all traffic control measures according to the KYDOT Standards.

Contractor shall be responsible for cleanup of materials left over resulting from prep work or actual paving and must be completed within 5 working days after the street is paved.

Contractor shall be responsible for the removal of any obstructions from the streets that should hinder completion of paving on specified streets such as, but not limited to, vehicles parked within the street right of way.

Contractor is not to be considered an agent or employee of owner for any purpose, and the employees of contractor are not entitled to any of the benefits that owner provides for owner's employees.

Contractor agrees to be fully responsible for any and all property damage or personal injury incurred by the acts of Contractor, his agents, servants or employees, and to hold the City harmless, as well as indemnify the City for any allegation of claim, direct or indirect, for personal injury or property damage as may be brought against the City by reason of any act of the Contractor, his agents, servants or employees, in carrying out the duties required of Contractor as set forth herein. Contractor shall maintain sufficient and adequate liability insurance with a minimum of \$2,000,000 general liability and \$1,000,000 per occurrence coverage as required by the City.

Contractor shall maintain workers' compensation insurance in the minimum applicable limits for the state of Kentucky, covering injury or death to any employee, agent or servant whom the Contractor employs or utilizes in the performance of his duties herein. Said policy of workers' compensation shall not be cancelled, altered or amended during the term of this contract without thirty (30) days prior written notice to City. Contractor recognizes as an independent contractor, Contractor is personally not covered by any workers' compensation insurance of the City and further acknowledges that the City has no liability whatsoever under the workers' compensation laws of the Commonwealth of Kentucky to Contractor individually, nor to any employee, agent or servant of Contractor during the performance of this contract.

# **BID FORM**

In compliance with the **Invitation to Bid**, BIDDER hereby proposes to perform and complete all work for **Asphalt Surfacing** in strict accordance with the **Invitation to Bid** for the price stated below.

By submission of this BID, each BIDDER certifies that this BID has been arrived at independently, without consultation, communication or agreement as to any matter relating to this BID with any other BIDDER or with any competitor.

BIDDER hereby agrees to commence WORK under this contract as soon as possible once notified to proceed by the Mayor of Elkton or his designee.

BIDDER acknowledges that he has read and understood all instructions and requirements regarding the submission of a bid, and is familiar with the project requirements and conditions.

BIDDER further affirms that he is experienced in the type of work proposed and competent to perform the work involved in the PROJECT.

Bids are to include permits and all other applicable taxes, licenses and fees.
