### BID SPECIFICATIONS TREE AND STUMP REMOVAL SERVICES

 The city of Elkton is accepting sealed bids for the removal of trees and stumps in several locations in cemeteries owned and operated by the city located on North Main Street and Pond River Roads in Elkton, Kentucky. Trees and stumps are currently marked with blue paint and described below:

# (a) Glenwood Cemetery:

- (i) Remove three (3) trees and stumps completely that are marked with a blue dot and located along the fence on North Main Street.
- (ii) Remove stumps along North Main Street along the fence.
- (iii) At main Glenwood driveway entrance on the right, remove one (1) tree and stump marked with a blue dot.

## (b) Elkton Cemetery:

- (i) Remove stump and tree and stump next to the new cemetery addition.
- (c) New Cemetery Addition:
  - Remove the tree line completely, including all stumps, trees, and shrubs, off Pond River Road in the new cemetery addition that is staked out with survey markers.
- 2. Contractor is required to provide traffic control as needed in compliance with Kentucky Transportation Cabinet regulations.
- 3. Contractor must furnish all equipment and materials to complete the contract.
- 4. Contractor must have proper liability insurance with minimum of \$1,000,000 coverage and worker's compensation insurance for any employees hired by contractor. Contractor will be required to provide certificate of insurance with the City of Elkton, Kentucky listed as an additional insured before contract begins.
- 5. Contractor must have a valid City of Elkton Occupational License (Business License) and must withhold City of Elkton Occupational License on gross wages (payroll tax) on all employees while working in the city limits of Elkton.
- 6. All work areas should be cleaned up and left in a smooth condition and ready to be sow.
- 7. Take extra care to protect all cemetery stones, iron fence, and blacktop driveways.
- 8. Contractor shall submit only the attached Bid Form indicating total bid price.
- 9. Work must be completed within forty (40) days of Notice of Award from the Mayor.
- 10. Payment will made to the contractor upon successful completion of the contract.
