

Minutes: Special City Council Meeting
June 17, 2024
8:00 AM

The Elkton City Council met in special session at Elkton City Hall, 71 Public Square, on Monday, June 17, 2024, at 8:00 AM with Mayor Arthur Green presiding.

City Council members present: Michael Case; Doug Gibson; Danny Laster; Frank McReynolds; George Orr; and David Powell.

Others present: Laura M. Brock, City Clerk/Treasurer; and, Robert Toombs, Chief of Police.

McReynolds motioned to read Summary of Ordinance 2024-05, "AN ORDINANCE AMENDING SECTION 97.21 OF THE CODE OF ORDINANCES OF THE CITY OF ELKTON ADJUSTING THE MONTHLY SERVICE FEE ESTABLISHED FOR RESIDENTIAL COLLECTION AND DISPOSAL OF SOLID WASTE MATERIALS" in lieu of the full ordinance, seconded by Powell, and carried unanimously. Clerk Brock read second reading of Summary of Ordinance 2024-05. Laster motioned to adopt Ordinance 2024-05 after second reading, seconded by Gibson, and carried unanimously by show of hands.

Laster motioned to read Summary of Ordinance 2024-06, "AN ORDINANCE ENACTING AND ADOPTING THE THIRTY-FIFTH SUPPLEMENT TO THE CODE OF ORDINANCES OF THE CITY OF ELKTON, KENTUCKY" in lieu of the full ordinance, seconded by Powell, and carried unanimously. Clerk Brock read second reading of Summary of Ordinance 2024-06. McReynolds motioned to adopt Ordinance 2024-06 after second reading, seconded by Powell, and carried unanimously by show of hands.

Clerk Brock read second reading of Ordinance 2024-07, "AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE CITY OF ELKTON, KENTUCKY FOR THE FISCAL YEAR JULY 1, 2023 THROUGH JUNE 30, 2024." Gibson motioned to adopt Ordinance 2024-07 after second reading, seconded by Powell, and carried unanimously by show of hands.

Clerk Brock read second reading of Ordinance 2024-08, "AN ORDINANCE RELATING TO THE ANNUAL BUDGET AND APPROPRIATIONS FOR THE CITY OF ELKTON, KENTUCKY, FOR THE FISCAL YEAR JULY 1, 2024 THROUGH JUNE 30, 2025." (Michael Case entered the meeting at this time.) Powell motioned to adopt Ordinance 2024-08 after second reading, seconded by Laster, and carried unanimously by show of hands.

There were no further items on the agenda, therefore the meeting was adjourned at 8:09 am.
