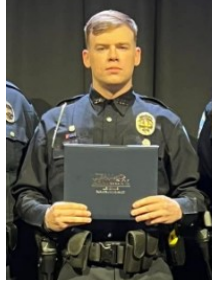

Monitor Your Water Pipes!

Now that the cold weather has arrived, there is an increased risk of broken pipes due to freezing and thawing of the ground, as well as pipes freezing under the house. We urge you to take steps immediately to prevent pipes from freezing, especially those located under the house or in the attic. If you have an **electronic read meter**, please make sure it's set up to send you alerts for high water usage. This function will notify you if there's a potential leak. If you need assistance in setting up this feature on your phone, please contact City Hall for help.



If you don't currently have an electronic read meter but are interested in adding one, let us know at City Hall, and we'll provide you with the necessary information.

Water Flushing



You may have noticed fire hydrants running water. This is part of a state-required procedure to ensure our water lines are properly flushed, maintaining high-quality water in the system. It also helps ensure all our fire hydrants are in good working condition. The city also continuously monitors our water lines to detect leaks and reduce water loss. Due to the location of some of our lines in the streets and the type of pipe that needs to be repaired, it may take several days or even weeks to complete necessary repairs. If you see pooling water or running water in your area, please notify City Hall. It could be a leak in the city's water lines or a possible issue with a private home's pipes. Planning & Zoning Reminders



1. If you are adding a building, fence, or an addition to your property, please check with City Hall to obtain the proper permits and information you need.
2. As homeowners or renters, it is your responsibility to maintain your property and ensure that items do not accumulate. We will provide courtesy reminders, and code violations may be filed if issues are not addressed.
3. Concerning animals in the city:
 - All dogs in public places should be on a leash, and you should cleanup after them if necessary.
 - Cats should not be allowed to roam or create a mess on your neighbors' property or doorsteps.
 - All outside animals should be kept in fenced-in areas that prevent them from roaming. Outdoor animals should always have access to shelter, food, and water.
 - Complaints about chickens will be addressed regarding the need for proper fencing and prevention of roaming.
 - Any animals roaming the streets or neighborhood yards are subject to being captured and removed from the city if not claimed. Owners may be subject to code violations for failure to properly care for their animals.
4. If you have trees or shrubs that extend into the streets or sidewalks, or block drivers' visibility of the road, they need to be trimmed or removed.

We have a beautiful city, and we thank everyone for your efforts in making improvements so that we can enjoy where we live. The city will continue to address concerns using the legal processes available. If you have any questions about city codes in these areas, please contact City Hall.
